2. Specific certification is required for specific positions.
3. Unless applicant already holds required certification(s) he/she must be prepared to take required certification course as soon as course is available.
4. All members of a team's staff must fill out a separate application including returning coaches and staff.
5. ALL Head Coaching applications must include a "Team Philosophy" document for review by Coaching Selection Committee.
6. Applicant(s) applying as a group must list all staff members in section 4 of the online application under "Additional notes pertaining to Application (or a separate document attach to hard copy application)." Not all staff members are guaranteed a spot.
7. All applicants must be interviewed by the coaching selection committee.
8. Filling out, submitting an application and being interviewed does not ensure a position.
9. ALL coaches must be approved by the current executive and no applicant should assume acceptance for any position until notified of approval by the Executive.
10. Please note, holding a position as a head or assistant coach during the previous/current season will be taken into consideration during selection, but does not guarantee retention of the same position for the next season.
11. No appeal shall be accepted as a result of not being selected as a coach or any other position.
12. Coaching a minor hockey team requires a commitment, be sure of your commitment.
